Welcome & Call to Order

Chair Fredman called the meeting to order at 12:02 p.m. ET.

Roll Call

 Director Searls called the roll. A quorum was established with 7 of 9 voting members present.

Review and Adoption of the Agenda

 Chair Fredman asked the committee if the agenda should be amended to add a discussion about vice chair nominations. • **Motion:** Dr. Miller made a motion to accept the amended agenda. Dr. Lisa Connors seconded the motion. The motion carried unanimously.

Review and Adopt Minutes

- Spelling amendment- Updated "sited" to "cited" in the last point under "review compliance checklist."
- **Motion:** Dr. Strait made a motion to accept the minutes as presented. Dr. Miller seconded the motion. The motion carried unanimously.

Review and Discuss FAQ

- N. Kalfas noted that other compacts are struggling to determine appropriate timeframes for reporting CSII (Current Significant Investigative Information). Most are considering a requirement to report within seven days of the board's determination that a hearing is warranted. When CSII is reported, the practitioner is flagged in CompactConnect.
- Director Searls confirmed the reporting timeframe may be set at the committee's discretion.
- Dr. Strait indicated that a shorter timeframe would be ideal, but seven days is probably more reasonable for boards. Dr. Connors and H. Koyt agreed.
- Dr. Robinson asked what the Compact does with the flagged information. N. Kalfas responded that this reporting is for compliance purposes and to alert participating states of the investigation.
- Dr. Robinson asked what would happen if an investigation were cleared. N. Kalfas
 encouraged the committee to determine a timeframe by which a state must remove
 a CSII flag if the investigation results in no findings. This should also be the
 timeframe a state has to ensure information is updated and accurate in
 CompactConnect.
- N. Kalfas and Dr. Connors emphasized the importance of states communicating directly with one another when questions arise about any of the actions listed above. State-to-state coordination is the first step.
- J. Moore suggested a consistent seven-business-day timeframe for: reporting CSII, reporting an adverse action, or reporting an investigation with no findings. Director Searls noted that Chapter 4 already establishes a reporting deadline to report within ten business days of determining an adverse action.
- N. Kalfas expressed concern that there would be liability for states if the flag is not lifted soon enough. With that feedback in mind, the committee discussed a fivebusiness-day reporting period for CSII.
- **Motion:** Mr. Moore made a motion to send the following recommendations to the Executive Committee:
 - Reporting of adverse actions: 10 business days

- Initial CSII flagging: 5 business days
- Removal of CSII flag when no findings result from investigation: 5 business days
- Grant authority to Director Searls, Ms. Kalfas, and the Chair to make nonsubstantive updates (e.g., formatting)
- Motion carried unanimously.

Discussing Vice-Chair

- Chair Fredman invited committee members to nominate a vice chair. Dr. Strait volunteered. Dr. Connors nominated Dr. Miller. Dr. Miller accepted the nomination.
- Per Director Searls, the Executive Committee will ultimately need to decide between the two candidates.

Next Meeting

- The committee discussed whether they should reschedule or cancel the next meeting because it falls on Labor Day. The committee determined it would be best to reschedule the next meeting.
- **Motion:** Dr. Strait made the motion to reschedule the September meeting to avoid the Labor Day holiday. The new meeting date: September 8, 2025, at 12 p.m. ET. Dr. Connors seconded the motion. Motion carried unanimously.

Chair Fredman invited questions and comments from those in attendance. No
questions or comments were raised by the other commissioners or the public.
