Welcome & Call to Order

Chair Speakman called the meeting to order at 12:03 p.m. ET

Roll Call

Director Searls conducted a roll call. Absences as listed above. A quorum was established with 23 out of 37 voting members present.

Review and Adoption of the Agenda

- K. Speakman called for a motion to adopt the agenda as presented.
- **Motion:** A. Irving made the motion to accept the agenda as presented. Dr. Robinson seconded the motion. All committee members present voted in favor; the motion carried.

Public Rules Hearing- Chapter 4: Data Set Requirements

Chair Speakman provided an overview of the hearing process in accordance with Compact procedures.

Vice Chair Brooks summarized the background and proposed amendments to Chapter 4, *Data System Requirements*, noting:

- The original rule became effective February 10, 2024.
- Subsequent versions incorporated clarifying edits regarding data reporting, FBI background checks, and use of NPI versus Social Security numbers.
- Additional revisions were made based on comments from the Compliance Committee, which recommended defining reporting timeframes for current significant investigative information (CSII). Comments from Louisiana led to further clarification of terminology, definitions, and data ownership language.
- After further comments from Louisiana and legal counsel review, the Rules Committee voted to recommend the removal of Section 4.3 (Data System Ownership) as it did not accurately represent the relationship between Compact commissions and CompactConnect.
- Minor formatting and numbering adjustments were made accordingly.

Motion: Vice Chair Brooks made the motion to approve the proposed amended rule, Chapter 4: Data System Requirements, as recommended by the Rules Committee, including the removal of Section 4.3 and related edits. J. Doming seconded the motion—all affirmative votes by roll call. Motion carried.
