**Chapter 9:** Rule on Consistent Credentialing

**Authority:** Section 9: Establishment of the Counseling Compact Commission  
Section 11: Rulemaking

**Definitions:**

“**Licensed Professional Counselor**” means a counselor licensed by a Member State, regardless of the title used by that State, to independently assess, diagnose, and treat behavioral health conditions.

“**Member State**” means a State that has enacted the Compact

“**Remote State**” means a Member State other than the Home State, where a Licensee is exercising the Privilege to Practice.

**9.0 Purpose:** Pursuant to Section 2.O, Section 2.S, Section 4, and Section 10:

- A. To amplify definitions existing in the Model Compact and to enhance public

protection by requiring compact participants to utilize a Privilege to Practice (PTP) designation when they are practicing pursuant to that PTP authorization. This designation seeks to distinguish between a single-state license and the PTP granted through the Compact.

- B. Licensed Professional Counselor means a counselor licensed by a Member State, regardless of the title used by that State, to independently assess, diagnose, and treat behavioral health conditions.
- C. Privilege to Practice means a legal authorization, which is equivalent to a license, permitting the practice of Professional Counseling in a Remote State.

### **9.1 Consistent Credentialing**

- A. A licensee participating in the Counseling Compact and holding privileges in other member states shall use the designation of Counseling Compact-Privilege to Practice-XX for a single privilege held or Counseling Compact-Privilege to Practice-XX, XX, XX when multiple privileges are held to designate their ability to practice under the Compact.
- B. The XX shall be replaced by the two-letter state abbreviation of the Remote State.
- C. The abbreviated credential must be used when practicing in the remote state when the actual license number is not provided.
- D. The abbreviated credential may be used in any professional communications, signatures, social media, or other documents in lieu of the actual privilege number when indicating their ability to practice.
- E. The Privilege to Practice is a legal authorization, which is equivalent to a license, permitting the practice of Professional Counseling in a Remote State.
